### **HOME OXYGEN SERVICES**

Further to my letter to you in August, I am now writing to advise that we have achieved a critical milestone in the Home Oxygen Service re-procurement. This is the stage where the NHS will take over responsibility for the selection and ongoing management of the Home Oxygen Service in each region.

In my last note, I informed you that we had issued an invitation to tender to pre-qualified bidders on 07 July 2010. Bids were received in September and working with colleagues from the NHS, they were evaluated and I am pleased to announce that all five bidders have been appointed to the National Framework. These are:

Air Liquide (Homecare) Limited  
Air Products PLC  
BOC Limited  
Dolby Medical Home Respiratory Care Limited  
Esteve Teijin Healthcare SL

We have invited the above suppliers and colleagues from the NHS to a 'Bidders Day' on Friday 10 December 2010 in London. The purpose of this event is for colleagues to meet and question all the suppliers and for them to present what they can bring to the region with a particular focus on quality and patient care. I am sure you will agree this as an important event and would encourage attendance from your region accordingly.

I had also mentioned that we intended to support the regions by including a pack of documents to assist in the call-off stage of the procurement. This pack has been delivered to your regional HOS Leads, and include templates for a transition project plan amongst other guidance documentation.

Although we continue to make progress we are now entering the key stages for the call off process. I trust your teams are taking the appropriate actions to ensure the re-procurement process is seamless to ensure continuity of care and oxygen supply for your patients.

Ministers are continuing to show an interest in the re-procurement of Home Oxygen. I would urge you to liaise with your region's Lead PCT Chief Executive to ensure that everyone in your region is prepared for the task ahead.
