1.	<p>Welcome & Introductions</p> <ul style="list-style-type: none"> • LCr welcomed all to the meeting and apologies were noted. 	
2.	<p>Minutes of previous meetings:</p> <ul style="list-style-type: none"> • Clinical Forum North meeting held 25 June 2019 The minutes of the previous meeting were agreed as an accurate record. 	
3.	<p>Matters Arising</p> <ul style="list-style-type: none"> • The new structure of the agenda for Clinical Forum North meetings was noted. • HT described that a 'how to' guide on exome sequencing was presented to Forum members recently. HT had received feedback from Sheffield Children's Trust that they would prefer to work on an individual basis and it was therefore agreed that the 'how to' guide will be a North only guideline. HT confirmed the 'how to' guide is now available on the website. 	
4.	<p>Clinical Topics</p> <ul style="list-style-type: none"> • NICE Guideline 124: Specialist neonatal respiratory care for babies born preterm https://www.nice.org.uk/guidance/ng124 <p>LM gave a presentation on the NICE guideline which was approved in April 2019. All were encouraged to consider the guidance as a team; assess their service against the guideline using the baseline assessment tool; change what can be changed; plan and discuss whatever cannot; and decide how to move forward in order to achieve compliance.</p> <ul style="list-style-type: none"> • Case presentation - Exome sequencing "if you can't label the phenotype can going straight to genome help" <p>CF gave a presentation on exome sequencing. CF described a recent case in which a baby was eventually diagnosed with Perlman Syndrome. It was noted that 53% of babies diagnosed die within the neonatal period. The parents were very keen for their baby to receive a diagnosis, and this was also noted to be important for their future family planning. There was good engagement between the genetic and neonatal teams. CF commented that one of the most important lessons she learnt from this case was how essential it to note any dysmorphic features that are present.</p>	All
	<ul style="list-style-type: none"> • ES gave a presentation on the investigation of the case described by CF. An antenatal array CGH (comparative genomic hybridisation) was undertaken on the baby in order to detect any possible chromosome change and the results came back normal. Due to the baby's unusual abdominal appearance and very large kidneys, a further sample was sent to Exeter for whole exome sequencing. ES and his colleague looked at the results again and decided to look at all genes that cause big baby syndrome, looking for a point mutation however none were found. They then moved on to CNV sequencing and this confirmed a diagnosis of Perlman Syndrome. This case has demonstrated the benefits and draw backs to the new approach. ES emphasised that obtaining a diagnosis is contingent on colleagues working together.

	ES informed the group that there were previously differences between antenatal and postnatal Array CGH testing. SS asked if this was still the case. ES will make enquiries and report back to the group.	ES

5.	<p>Network Topics</p> <ul style="list-style-type: none"> • Clinical Lead Update: <ul style="list-style-type: none"> ○ Neonatal Critical Care Transformation Project (previously Better Newborn Care)/Transformation/Extreme Preterm BAPM document update The group were informed that there was a further delay with the publication of the document with a new release date potentially in December 2019. It was noted that when the document comes out there may be a less rigid approach around the accepted amount of activity care days when looking at resignation of units. The consultation period for the Perinatal management of extreme preterm birth before 27 weeks of gestation: A Framework for Practice BAPM document was now over. While awaiting the outcome of the consultation, all were asked to start thinking about in utero transfers 22-23 weeks gestation, this would be significant for maternity and neonates, as well as the active care options that are going to be offered. ○ Clinical Reference Group It was noted that an updated neonatal service specification document will hopefully be available in 2020. ○ Recording Encephalopathy on BadgerNet The group was informed that there had been an issue on one of the units with regard to data recording of HIE, and its associated signs and symptoms on BadgerNet. The unit had been identified by the NMPA (National Maternity Perinatal Audit) as recording particularly high numbers of HIE. NMPA gather data on all 35+ singletons with 3 signs and symptoms 1. Consciousness, 2. Tone, 3. Convulsions, the Network has since assisted the unit with the cleansing of their data. Some of the signs and symptoms were attributable to other conditions and not just HIE. It was also noted there was lots of variation in the grading of HIE for those particular babies transferring to other units for treatment. All were encouraged to be aware of the above when inputting data. Please ensure that all data particularly around HIE grading, that the final diagnosed grade was correct at time of discharge. The Network has informed NMPA of potential issues around the information they are collecting. 	<ul style="list-style-type: none"> ● Lead Nurse Update: <ul style="list-style-type: none"> ○ Thermoregulation/ATAIN/TC DE asked all to ensure they are aware of their ATAIN lead. LM suggested that at the next meeting Trusts share experiences. It was suggested that midwives be invited to the next meeting to discuss improvements introduced in their Trust that had made a difference. Thermoregulation information sent out from AJ, ODN Information Team, was considered very helpful by all. A request was made that a run chart for each unit be included in order to show progress. AJ to action. ○ Staffing/workforce DE gave an update on staffing and workforce within the Network. It was agreed that DE would action the request for information with regard to workforce baseline figures. ○ Parent Passport Family Integrated Care Update LCr informed colleagues that following a recent parent passport meeting the group will now start introducing the FiCare model/ family involvement in care to their individual units. The first part of the process will be an introduction to the model using a poster presentation primarily aimed at the staff. A resource file for staff to access will also be made available. It was felt as a group that the whole care package that parents work through should be the same for all the Network units, and as such the group would consider/utilise packages that were already available to avoid re-inventing the wheel. HT asked that anyone from a Level 2 unit who would like to be involved please contact her. EC will ask her colleagues. It is hoped that following circulation to Clinical Leads, both Medics and Nursing that this guideline can be presented at the December Exec Group for ratification. • Lunchtime teaching "webinars" HT informed colleagues of teaching webinars that the team would like to provide once a month, perhaps 40 minute sessions on specific topics. It was agreed that a recorded version may be more practical, such as a 20 minute podcast. 8.	<p>Any Other Business</p> <ul style="list-style-type: none"> • Car seats LCr asked all to be aware of the RoSPA Road Safety Research guidance. • Transwarmers A MRHA alert had been circulated about transwarmers. HT reminded the group that when you activate the transwarmer, it warms up by 10 degrees. Be aware not to activate it inside the incubator or whilst on the Resusitaire while on as this could burn the baby. Do not store it in incubator, rather store it at normal room temperature and activate it outside of the incubator. Good temperature monitoring of your baby is essential to ensure safety.
